Waiver and Release of Liability
Agreement to Indemnify

I, _____, understand that the garden activities can be dangerous depending on what is being done and may involve a variety of risks, including exhaustion and/or serious physical injury, including brain damage, paralysis or death.

1. **I EXPRESSLY DECLARE AND AGREE TO ASSUME THE ENTIRE RISK OF ANY AND ALL DAMAGES, OCCURRENCES, ACCIDENTS AND PERSONAL INJURY, INCLUDING BUT NOT LIMITED TO DISABILITY OR DEATH, THAT I MAY SUFFER WHILE PARTICIPATING IN THE ACTIVITIES.** I hereby undertake and agree to respect and comply with all applicable laws, rules and regulations governing the Community Garden and to comply with directions and/or instructions given. I shall be responsible for all fines, penalties and property damage I may incur, personal injuries or property damage incurred by others as a result of my conduct when participating in the Activities.
2. I have familiarized myself with the rules applicable for use of the Community Garden. I agree to obey the rules and safety guidelines and acknowledge that such rules and safety guidelines apply to me in all cases.
3. I agree that I will not be under the influence of alcohol, drugs or anything that could impair my faculties and/or judgment while engaged in the Activities.
4. In consideration of the above, I, on the behalf of myself, my spouse, heirs, assigns, successors, beneficiaries, executors, attorneys, and all other legal and/or personal representatives, agree to waive, release, not to sue Muskingum Soil and Water Conservation District, Muskingum County and the Board of Commissioners, and/or their employees, officers, volunteers, supervisors, representatives (Released Parties), and the landowner of and from any and all actions, causes of actions, claims, demands, damages, losses, costs, expenses, compensation, rights, debts, liabilities, obligations, disputed, controversies, and payments of any kind and character, known or unknown, existing or contingent, regarding, arising from, growing out of, or in any way related to the Activities, the conduct of the Released Parties, or my own conduct, whether or not due to my own negligence, acts or omissions, or the negligence, acts or omissions of other third parties, or the Released parties, for any and all known and unknown personal injuries, death, disabilities, damages or intangible damages occurring at the time hereafter.
5. I hereby agree to indemnify, defend, and hold harmless the Released Parties against any and all claims, demands, actions, causes or action, liability, losses, damages, costs, expenses and reasonable attorney's fees, which Released Parties may incur in any way related to my conduct or my participation in the Activities.
6. I hereby acknowledge and agree that no representation or warranty of any kind or nature whatsoever has been given to me regarding the condition of any facilities. I agree that the Released Parties shall not be liable for any alleged negligence pertaining to the condition of the facilities.
7. This waiver/release contains the entire agreement between me and the Released Parties, and the terms of the release/waiver are contractual. This waiver/release may not be modified in any way. If any part of this waiver/release is determined to be invalid by law, all other parts of this waiver/release shall remain valid and enforceable. This waiver/release shall be governed by the laws of the state of Ohio.

8. Photography Release - I hereby authorize Muskingum Soil and Water Conservation District to publish photographs taken of me at the Community Garden and my name and likeness, for use in print, online and video-based marketing materials, as well as any other publications.

I hereby release and hold harmless Muskingum Soil and Water Conservation District from any reasonable expectation of privacy or confidentiality associated with the images specified above.

I hereby release Muskingum Soil and Water Conservation District, its contractors, its employees, and any third parties involved in the creation or publication of marketing materials, from liability for any claims by me or any third party in connection with my participation.
